

**COMPOSITION:** 1 capsule contains: *active ingredients:*

**Gymnema leaves extract (Gymnema Sylvestre) - 150 mg,**

**Banaba leaves extract (Lagerstroemia speciosa) - 125 mg,**

**bitter melon extract (Momordica charantia) - 100 mg;**

*excipients: filling agents:* calcium stearate, silica dioxide amorphous, micro-crystalline cellulose; *capsule shell:* gelatin.

**NUTRITIONAL AND ENERGY VALUE (CALORIC VALUE) PER 100 g OF THE SUPPLEMENT:** proteins - 15.0 g, carbohydrates - 1.1 g, fats - 0 g; 64.4 kcal (296 kJ).
