

RESVERASIN[®]



COMPOSITION: 1 capsule contains: *active ingredients:*

resveratrol - 150 mg,

red wine extract - 100 mg,

grape seed extract - 50 mg;

excipients: filling agents: microcrystalline cellulose, lactose, calcium stearate, silica dioxide amorphous; *capsule shell:* gelatin.

NUTRITIONAL AND ENERGY VALUE (CALORIC VALUE) PER 100 g OF THE SUPPLEMENT: proteins – 19.0 g, carbohydrates – 1.3 g, fats - 0 g; 345.1 kJ (81.2kcal).

RECOMMENDATIONS FOR USE: RESVERASIN[®] is recommended as an additional source of resveratrol, polyphenols and proanthocyanins demonstrating potent antioxidant properties to normalize the metabolism and restore staying power.

RESVERASIN[®] is suitable for the improvement of a person's vitality and the slowdown of physiological aging; in case of impaired nervous, cardiovascular and endocrine systems functioning, as well as in ophthalmic, gynecological and urological conditions, when preparing for pregnancy, for persons with impaired immunity, in case of fatigue and nervous exhaustion. It improves metabolism in metabolic syndrome, increases the insulin sensitivity of cells in type 2 diabetes. It has a detoxification effect, binds and neutralizes free radicals in all conditions associated with an oxidative stress. It attenuates the negative impact of toxins in nicotine dependence. It is recommended for persons, who live in an ecologically unfavorable environment, in order to eliminate the negative impact of harmful environmental factors; as an adjunctive natural complex to reduce the toxicity of chemotherapy in cancer patients. It improves collagen synthesis and has a beneficial effect on skin regeneration. **RESVERASIN[®]** is natural complex that contains a number of highly active natural antioxidants.

METHOD OF ADMINISTRATION AND RECOMMENDED DAILY DOSE: adults should take 1 capsule 1-2 times daily after meals swallowed with plenty of drinking water. The treatment course is 2-3 months. The course can be repeated if needed.

CONTRAINDICATIONS: individual intolerance of the ingredients, pregnancy and breastfeeding.

Do not exceed the stated recommended quantity for daily intake.

Should not be used as a substitute for a balanced diet.

PHARMACEUTICAL FORM: capsules with the contents weight of 360 mg \pm 7.5 %.

STORAGE CONDITIONS: store in the original package at temperatures 4 to 25°C, in a dry place protected from light, out of reach of children.

MANUFACTURING DATE: see the manufacturing date on the package.

SHELF LIFE: 24 months from the manufacturing date.
